Distribution for Pulitzer: Marjorie Miller, Administer of The Pulitzer Prizes and all members of the Pulitzer Board and the Pulitzer Poetry Prize Judges.

Distribution by Dr John WorldPeace JD: All the publishers of poetry listed in the 2020 Writers Guide for Poetry, and the English departments of many Universities at the rate of about 5,000 emails a day until the prize is awarded,

1) Well Ms Miller only 10 days until the May 9th, announcement of the 2022 Pulitzer winners. Still no time set. Interesting.

2) By this email, I am filing a formal objection to Amanda Gorman filing two books that appear to be the same but may not be. I cannot find out. But I feel that Ms Gorman Publishers have received under the radar communication that she will win the 2022 Pulitzer Poetry Prize and I think that information was passed to Viking Press, Ms. Gorman's publisher, the second week of January 2022. The Hill and CNN on January 23, 2022 said that Viking was going to print a million copies of 3 books by Ms. Gorman. See the many attachments on this matter.

The Hill we Climb ISBN 9780593465271 was to get a second run April 27, but that was moved up to March 31.

So why would they do that. Well April 27 is too late to begin publishing a million books when the Pulitzer Announcements will be on May the 9th.

In the Library of Congress ISBN records Ms Gorman's, Viking, published a Poetry Book called "The Hill We Climb and other poems." as ISBN 9780593465073. This book was published in July 2021. Then they published the same book under the title "Call us what we carry : poems" as ISBN 9780593465066. This book was published on December 17, 2022.

There is a note in the Library of Congress records that said 9780593465073 was now invalid.

Both of these books are for sale all over the internet. But what is happening is that there is various graphics of "The Hill we climb and other poems" But the book that ships in the details is Call Us What we Carry : Poems.

You cannot find on the internet a copy of "The Hill we climb and other poems."

You will also find in the attachments there are a few more ISBN numbers referenced for Call us what we carry : poems. All this is crazy.

But here is a way to make sense of it. Viking screws up in July 2021 and prints a book "The Hill we climb and other Poems." Which can easily get confused with "The Hill we climb" the inauguration poem.

So Viking realizes that they are going to lose a lot of sales due to the confusion. So they jump in a retitle "The Hill we climb and other poems" to Call us what we Carry : Poems."

But there is another problem. Viking submitted "The Hill we Climb and other poems for the Pulitzer Prize. Now they have to get "Call us what we carry: poems" submitted. And according to the Pulitzer rules you have to have your book printed by the October deadline UNLESS THE PRINTER writes a letter to Pulitzer and promises to publish the book before the end of December which they did.

Now if I remember correctly the Pulitzer application warns the submitter that they cannot change the application. So this book with the same content was submitted under "The Hill we Climb and Poems" first, then turned around and submitted it again under "Call us what we carry : poems".

Now you cannot submit the same exact book with two titles for the Pulitzer. Poetry Prize. So what did they do, change their initial submission which is against the rules. Or did they try to withdraw that application and run on the second application.

It is critical that Viking have Call us What we carry: poems on the Pulitzer Prize Award.

Well without Dr John WorldPeace JD in the mix all this could be swept under the carpet. But really there is a good chance that average Americans would see all this confusion as manipulation and corruption at Pulitzer and Gorman and others.

What is not obvious, is that someone at Pulitzer on the Board, or Bud Kliment, or Marjorie Miller or the judges, or who knows who, sent out the alert to Viking that Amanda Gorman was going to win the prize. I would think every American would expect her to win. But the problem is the millions of dollars lost with "The Hill we climb" listed on the Prize.

You know who has the power to deliver the Pulitzer Poetry Prize to Ms. Gorman. Oprah Winfree. How many of the Pulitzer Prize board members does she know. She needs replacements for Toni Morrison and Maya Angelou. But someone who will keep their mouth shut about "The Hill We Climb" issues and not be a Rosa Parks or Harriet Tubman.

Now if Ms Gorman wins, the Pulitzer Prizes is going to lose credibility, as will Ms Miller, and Viking and most importantly Ms Gorman is going to be seen as a lying little Black bitch at least by the White community. And where they thought they had a nice conservative Oprah endorsed Black female to win the prize, everything crashes and shit flies all over.

Then there is All those book sellers on the internet that are putting up "The Hill we Climb" for sale and shipping Call us what we carry"

Several months ago I, knowing what was going on and looking for the original copy, made a specific request to Biblio that I wanted The Hill we Climb because that is what was on their advertising graphic. They shipped Call us what we Carry. I complained and filed with my credit card company and Biblio did not respond and I got my money and kept the book which they did not ask for.

Now part of the Pulitzer Prize for Poetry is about the cover of the book. That is part of the winning metric. So what about that issue. And since no one can find a copy of The Hill we Climb and poems" how do we know if the two books are, except for the cover, the same exact book?

Now here is another thing, where Viking and Ms Gorman have a committed plan to publish 3 million books. That is pretty outrageous for someone unless they are guaranteed a win of the Pulitzer Poetry Prize. So the actions of Viking, Ms.Gorman's agent, sure look like they got notice Ms. Gorman was going to win as early as the second week of January.

They did not have a big epiphany the second week of January, about promoting a book , "The Hill we Climb -the inauguration poem" which had already had a year surge was going to take off again without a Pulitzer Prize. No way

Ms. Gorman has not written any poetry for 18 months. And let me tell you this, no parent is going to buy a Childrens Book, unwritten, from a young woman who has no children.

Yes Viking, over played their hand.

Someone at Pulitzer also was pretty confident that no one would figure this out. And I am sure that was a good bet regarding the entire world human society but does not apply to Dr John WorldPeace JD.

And here is a couple more issues I just realized. 1) Jericho Brown who won the prize in 2020 worked for the Tufts Prize before he won. Point is that this whole top end poetry prize collective are corrupt. They keep the prize in the family of university poets with accolades and they hand out the accolades in a corrupt and conspiratory manner.

2) The other thing I realized is that a bigger than normal average of Columbia connected poets have won the prize. I have not done a thorough enough research on this. In my research, I just looked at the last 20 years of winners and not so closely at where these winners taught. I only saw today that Gwendolyn Brooks taught at Columbia. So I need to take a closer look, and farther back regards to the Pulitzer winners to see how many were connected to Columbia in any way.

Folks I have been psychic all my life. I could make a living as a fortune teller. But I had no interest in using my gift like that. I have used it to increase the peace in the world human society. But the above comes from my 53 years working with small businesses, and the Pulitzer Prize is a business. That is a big problem with the Pulitzer Poetry Prize, the prizes are decided based on business arrangements. Consider this, no one has ever as far as I remember won the Pulitzer Poetry Prize who self-published. For Pulitzer to give the Poetry Prize to me, a self publisher, in today's reality of self publishing and promoting, would betray all the Publishers of poetry they have worked with for years.

That said, I practiced law for 20 years. I know how to organize evidence. All the poetry submitters and winners to date, do have the blood lust of a lawyer.

The Pulitzer took my money and my 4 volume, 2700 page, 3300 poetry 2020 submission they threw it in the trash. They have never denied this. and they handed the prize to a Tufts employee and Black Gay fellow writing about his gay fantasies and turned their back on someone who has been writing poetry significantly for 53 years and who is an rabid advocate for WorldPeace for the last 34 years.

Well, we are going to see in a week, if they are going to screw me again.

Let me tell you one more thing about Ms. Gorman. All that blah blah blah she put into her inauguration poem, she has written nothing since. She has not sponsored any little Black girls for anything. She does not have one single solution to all the problems her poem discusses. Do you think she is going to join the military and serve her country. Not likely. Ms Gorman is a pretty little show horse.

Not she or any other professor poet is going to advocate any aspect of WorldPeace because no matter what you say about any Peace issue, you are going to create division and conflict and lose sales and if you are a professor lose your job,
